



# Spiritually Speaking

## Circles, Squares, and Triangles

What shape are you? Whatever shape you are, you were created that way for a specific purpose. God formed every creature on this planet with a special area of expertise. Some animals run, some hop, some swim, some burrow, some slither, and some fly. Each has a particular role to play, based on the way they were shaped by God.

The same is true of humans. Each of us was uniquely designed, or “shaped”, to do certain things. Before architects design a new building, they first ask what is the purpose of the building and how will it be used? The intended function of the building determines the form and shape of the building.

Before God created us, God decided what role we were to play on earth. You are the way you are because you were made for a specific purpose. The Apostle Paul, in his letter to the people at Ephesus, wrote, “We are God’s workmanship, created in Christ Jesus to do good works.” Our English word “poem” comes from the Greek word translated “workmanship.” You are God’s handcrafted work of art.

You are not an assembly-line product, mass-produced without thought. You are a custom-designed, one-of-a-kind, original masterpiece. God deliberately shaped and formed you in a unique way. God carefully mixed the DNA cocktail that created you.

The Psalmist wrote: “You made all the delicate, inner parts of my body and knit me together in my mother’s womb. Thank you for making me so wonderfully complex! Your workmanship is marvelous.” God doesn’t make junk.

Nothing that happens in your life is insignificant. God uses all of it to mold you and shape you for your ministry to others. God never wastes anything. God would not give you abilities, interests, talents, gifts, personality, and life experiences unless God intended to use them to help make you who you are.

You are wonderfully complex, as David said. You are a combination of many different factors. God always gives us the capabilities to do what God asks us to do and to be who God wants us to be.

God loves variety and wants us to be special. No single gift or ability is given to everyone. Also, no one individual receives all of God’s gifts. If you had them all, you would have no need of anyone else, and that would defeat one of God’s purposes – to teach us to love and depend on each other.


Your gifts were not given for your own benefit but for the benefit of others, just as the gifts given to others are for your benefit. God planned it this way so that we would need each other. When we use our gifts together, we all benefit. If someone doesn’t use their gifts, they get cheated.

The Bible uses the term “heart” to describe the bundle of desires, hopes, interests, ambitions, dreams, and affections you have. Your heart represents the source of all your motivations – what you love to do and what you care about most.

Proverbs 27:19 – As a face is reflected in water, so the heart reflects the person.

Your heart reveals the real you – what and who you truly are, not what others think you are. Your heart determines why you say the things you do, why you feel the way you do, and why you act the way you do. ▼



# In My Words

a personal viewpoint

Full text of proposed Amendment 2 to the Florida Constitution: "Inasmuch as marriage is the legal union of only one man and one woman as husband and wife, no other legal union that is treated as marriage or the substantial equivalent thereof shall be valid or recognized."

I have never been a big fan of bumper stickers, but this one really fits our situation in Florida right now: "If you are not outraged, you are not paying attention." No kidding. I am outraged and I am telling everyone I know. In this great state, Gays and Lesbians are *already* not allowed to marry, in addition to not being allowed to adopt...I would have thought that would be enough discrimination for one state, even one as big as Florida.

I thought that if I, and all of the other people in the GLBT community, tell everyone we know...family, friends, co-workers...then we should easily defeat this Amendment which is an attempt to write discrimination into our State Constitution. However, according to the latest Mason-Dixon poll on August 29<sup>th</sup>, 57% of Floridians support passage of Amendment 2!

Once again, I am outraged. This tells me that we are not stepping up and making our voices heard. My challenge to you is to tell everyone you can. If this amendment passes, not only will my partner and I likely have to relocate to another state (where we will be recognized as a legal couple), but it will rob senior citizens of their basic rights while sending a clear message to the entire state that discrimination is okay, even condoned.

If you think we had too many hate crimes over the past 12 months, just wait until you see the ripple effect this amendment will have. Once it passes here, "Florida 4 Marriage," the group responsible for placing it on the ballot, will go after abortion rights and the divorce laws. The amendment will be pushed in other states, by similar organizations, who have learned how to manipulate the amendment for passing by using confusing wording and campaigning at area churches.

Florida 4 Marriage says that the amendment does only one thing-protect marriage. I don't really understand how allowing gay marriage (or any other legal union) threatens marriage between one man and one woman. I can understand that they feel the need to protect those marriages, since they currently have a failure rate of between 41-73%, depending upon whether it is your first, second, or third marriage.

The group says that the amendment will not take away any existing rights or benefits from anyone. Tell that to the residents of the state of Michigan, where an amendment was placed on their constitution in 2004 and where their Supreme Court just ruled that amendment means that city and county agencies may no longer offer domestic partnership benefits.

Florida 4 Marriage claims that the Amendment will "protect children," claiming the legislation is necessary to keep educators from teaching that gay marriage is equal to "natural marriage." Once again, this screams that discrimination is okay and condones

the actions of individuals like 14-year-old Brandon McInerney, who shot and killed his classmate, Lawrence King, for being gay.

The group claims that it is necessary to write discrimination into the Florida State Constitution because it "...gives children the best chance for both a mom and a dad." They are basically saying that when gay people are banned from marrying in Florida, they will see the error of their ways and become heterosexual, or that people like myself will end a gay relationship in favor of a "legal" relationship.

As I said earlier, we are already not allowed the same benefits of marriage that heterosexuals are...that has not stopped us from living our lives and taking care of our families. I am certainly not going to leave my partner because the State of Florida adds an amendment to their constitution. I might leave Florida, but I will not leave my partner.

I know we can defeat this amendment and protect our families from further inequity. We vote! The 2004 Gay and Lesbian Consumer Online Census showed that 88% of the adult GLBT population is registered to vote, while only 66% of the general population is registered. The census also indicated that 80% of the GLBT community regularly cast ballots – a full 20% higher than the general population.

Here's the problem with those numbers: the GLBT population only accounts for, on average, about 8-10% of the total population in Florida. Again, this means that you have to tell everyone you know. No need for a snazzy sales pitch or a long, drawn-out political debate. I usually tell people that I don't care WHO they vote for (for President) as long as they vote *NO* on 2. ▼



for the various events that will be scheduled throughout the year to celebrate this chapter of faith life at Family of God.

**Gay Rights Tidbit:** The elections are coming up in a few short weeks and it is very, very, very important that each of us go out and talk to our friends and neighbors about Amendment 2. All the intellectual arguments that various organizations can present will change very few minds; it is person-to-person interaction that makes the difference.

As we attend various functions where politicians are present we have taken to asking Republicans "Why do you hate me?" In the vast majority of the situations the individual is genuinely hurt at the thought that a complete stranger thinks they hate them. Now you have to be brave and tell them you're gay (it's much easier than you think when the person you're talking to is off balance). Very few will turn away, most reply that they don't hate me, that they have gay friends, that they have nothing against gays. Then we ask them why their party spent \$300,000 to finance Amendment 2.

Suddenly they have to defend the indefensible, they have to rationalize why their party would single out one part of law abiding, tax paying American citizens to legislate against. They stutter. They stammer. They hem and haw.

At this point some will fall back to the tired religious argument and when we

TEQUESTA—In concluding collective bargaining with its three unions, the Village of Tequesta has expanded the definition of “immediate family” to include employees’ domestic partners.

The new definition is included in the contracts between the Village and the Professional Fire Fighters/Paramedics of Palm Beach County, the Communications Workers of America, and the Palm Beach County Police Benevolent Association. The three contracts are in effect through September 30, 2010.

“Once again, the Village of Tequesta has taken steps to ensure that all Village employees are treated equally,” said Rand Hoch, President of the Palm Beach County Human Rights Council.

The Council, a non-profit GLBT rights organization, first began working with the Village on employment issues in 2007.

Last year, Tequesta became one of the first municipalities in Florida to prohibit discrimination based on “gender identity or expression.”

ANCHORAGE— According to a September 9th article in the Huffington Post, Gov. Sarah Palin’s church is promoting a conference that promises to convert gays into heterosexuals through the power of prayer.

“You’ll be encouraged by the power of God’s love and His desire to transform the lives of those impacted by homosexuality,” according to the insert in the bulletin of the Wasilla Bible Church, where Palin has prayed for about six years.

Palin’s conservative Christian views have energized that part of the GOP electorate, which was lukewarm to John McCain’s candidacy before he named her as his vice presidential choice. She is staunchly anti-abortion, opposing exceptions for rape and incest, and opposes gay marriage and spousal rights for gay couples.

Focus on the Family, a national Christian fundamentalist organization, is conducting the “Love Won Out” Conference in Anchorage, about 30 miles from Wasilla.

Palin, campaigning with McCain in the Midwest on Friday, has not publicly expressed a view on the so-called “pray away the gay” movement.

Gay activists in Alaska said Palin has not worked actively against their interests, but early in her administration she supported a bill to overrule a court decision to block state benefits for gay partners of public employees.

Palin reversed her position and vetoed the bill after the state attorney general said it was unconstitutional. [like she reversed re position on “The Bridge to Nowhere” after the public outcry against it – ed]

“I think gay Republicans are going to run away” if Palin supports efforts like the prayers to convert gays, said Wayne Besen, founder of the New York-based Truth Wins Out, a gay rights advocacy group. Besen called on Palin to publicly express her views now that she’s a vice presidential nominee.

“People are looking at Sarah Palin as someone who might feasibly be in the White House,” he said.

ANNAPOLIS—Parents, Families and Friends of Lesbians and Gays (PFLAG) applauded a Maryland Appeal Court ruling today which dismissed attempts to roll back landmark protections for transgender residents in Montgomery County, Maryland, by way of a November ballot initiative. The court’s unanimous ruling ends a campaign by anti-transgender activists to strip the county’s civil rights law of protections based on gender identity. The law was amended in November 2007 and, because of this ruling, will now be enacted to include the transgender community.

“The anti-transgender campaign in

Montgomery County was based on bigotry and fueled by misinformation,” said Jody M. Huckaby, executive director of PFLAG. “It was being forced onto the ballot with no regard for state law or the fundamental rights of our transgender neighbors and allies. Today’s ruling sends a clear message that opponents of equality are not above the law, and our transgender loved ones are not below it. Montgomery County’s civil rights law offers important protections to transgender and gender-variant people. We join our allies in Maryland and the transgender community in celebrating its long over-due enactment.”

Lambda Legal, together with counsel from Equality Maryland, represented state residents who fought efforts by the far-right Citizens for Responsible Government (CRG) to place the measure on the fall ballot. The groups argued that CRG did not collect the required number of valid signatures to qualify for placement on the ballot, and that a lower court acted improperly when ruling that, despite the lack of signatures, the initiative could move forward. In today’s ruling, the court sided with Lambda Legal and Equality Maryland, shutting down any future attempts for a vote on the issue. The National Gay & Lesbian Task Force, The National Center for Transgender Equality and Basic Rights Montgomery also played critical roles in defeating the initiative.

“Today’s ruling is a significant victory for every American who believes that every member of our family is worthy of dignity and respect,” Huckaby said.

PFLAG also opposes similar efforts to block transgender rights laws in Gainesville, Florida and Hamtramck, Michigan. For more information on PFLAG’s work with, and on behalf of, the transgender community, visit [www.pflag.org](http://www.pflag.org).

WASHINGTON, DC—From a *Washington Blade* interview with Barak Obama:

**Blade:** Important gay rights legislation unrelated to marriage has been stalled in Congress for quite some time. The gay community has high expectations for an Obama administration. What are reasonable expectations for a first-term Obama administration: How aggressively would you push for Congress to pass ENDA, the hate crimes bill, repeal of “Don’t Ask, Don’t Tell,” and other gay-related bills in your first year in office, and would you mention those bills in your State of the Union address?

**Obama:** These bills are all important priorities for me. Senator Biden and I have long committed ourselves to supporting fundamental civil rights for all. In addition to the issues you mentioned, I also support full repeal of DOMA to provide equal federal rights and benefits to LGBT couples. America must live up to our founding principle of equality for all, and it’s wrong to have millions of LGBT Americans living as second class citizens in this nation.

I support these efforts because I know that equality is a moral imperative. Back when I was in the Illinois Senate, I co sponsored a fully inclusive bill that prohibited discrimination on the basis of both sexual orientation and gender identity, extending protection to the workplace, housing, and places of public accommodation. The non-discrimination bill has become law in Illinois. If I am honored to serve as your President, I will continue to do what I’ve done throughout my career and in this campaign: speak out on behalf of the cause for equal justice and opportunity for LGBT Americans.

FT LAUDERDALE—In an article in *The Washington Blade*, Key changes Gospel singer Ray Boltz shared his coming out journey.

Boltz, 55, is well known in the Contemporary Christian Music genre with some 4.5 million recordings sold. However he has never broken out to wider fame and never really tried.

Following a visit to the mostly gay Jesus Metropolitan Community Church in Indianapolis, while there visiting his family, Boltz gave the pastor a copy of his 1997 holiday recording, "A Christmas Album."

"I didn't make a big deal of it," Boltz said during a 90-minute phone interview from his home in Ft. Lauderdale, Fla. "But I was trembling. I'd kind of had two identities since I moved to Florida where I kind of had this other life and I'd never merged the two lives. This was the first time I was taking my old life as Ray Boltz, the gospel singer, and merging it with my new life. Emotionally it was kind of a big deal to think about that."

Boltz was married for 33 years and has four grown children. Family life and going through the motions of being straight had grown so wearying to Boltz, he was in a serious depression, had been in therapy for years, was on Prozac and other anti-depressants and had been, for a time, suicidal.

Finally in 2004, Boltz came out to his family.

"I thought I hid it really well," he says. "I didn't know people could see what I was going through, the darkness and the struggle. After I came out to my family, one of my daughters said she was afraid to walk in my bedroom because she was afraid she'd find me — that I'd done something to myself. And I didn't even know they'd picked it up."

"It's hard to say I came out because I didn't have all the answers. I just admitted what I was struggling with and what I was feeling. It's hard to go, 'This is the point where I accepted my sexuality and who I was,' but I came out to them and shared with them what I'd been going through."

He and Carol separated in the summer of 2005 and he moved to Ft. Lauderdale, Fla. He only casually knew a few people there but thought it would be a good place to start a new, low-key life and get to know himself.

He and Carol Boltz remain close (their divorce was finalized early this year). She's become involved with the gay advocacy group Soulforce but declined, through Boltz, to be interviewed.

The name on the CD didn't register with MCC's Rev. Jeff Miner at first. And that was just fine with Ray Boltz.

Miner showed the CD to the music leaders at MCC Indianapolis who, recognizing Boltz's name, were dumbfounded that he'd been to their church. When they mentioned some of Boltz's hits to him, Miner made the connection.

Miner told Boltz if he was ever in the area again — Boltz makes regular trips back to the Midwest to visit family — that he was welcome to sing.

This started a chain reaction of events that led to this story. Boltz performed at Miner's church to an enthusiastic reception. Miner then introduced him to Rev. Cindi Love, executive director of the Fellowship of Metropolitan Community Churches, who'd just released a book called "Would Jesus Discriminate," a discussion of Christianity and homosexuality.

Love invited Boltz to join her at MCC Washington where he sang on May 25 and, even though it was not stated that Boltz is gay, the congregation connected with the songs.

"I didn't tell them I was gay but I still felt like

I was being authentic, that I could be who I was," Boltz says. "They all jumped up at the end of the song, clapping and all gave me hugs. It was pretty amazing."

Boltz is clear, though, about his reasons for coming out publicly.

"I really had no master plan here," he says. "I've just been trying to go with the idea that you can either live your life out of love or out of fear. I could just stay here in Florida and be pretty anonymous. I could go work at Wal-Mart or something where nobody knows who I am, but to me, that's kind of living in fear."

Though he's open to performing, Boltz says he doesn't plan to let this issue take over his life.

"I don't want to be a spokesperson, I don't want to be a poster boy for gay Christians, I don't want to be in a little box on TV with three other people in little boxes screaming about what the Bible says, I don't want to be some kind of teacher or theologian — I'm just an artist and I'm just going to sing about what I feel and write about what I feel and see where it goes."

WASHINGTON, DC—HRC has hit the million mark! They are up to 1,003,118 signatures on their Million for Marriage petition.

HOLLYWOOD—Decades ago, networks titled shows for the sponsors that paid the bills, among them "Kraft Music Hall," "Schlitz Playhouse of Stars," "Camel News Caravan" and "Colgate Comedy Hour." Now, a familiar apparel label is teaming up with a cable channel to lend its name to 30 weeks of "unbuttoned" programming. The Levi's 501 button-fly line of jeans sold by Levi Strauss

& Company is joining with the Logo unit of MTV Networks, owned by Viacom, for a campaign called "Logo Unbuttoned." Promotions for the campaign are scheduled to begin on Tuesday on Logo, a network aimed at gay and lesbian viewers that since its introduction in June 2005 has signed sponsorship deals with other mainstream marketers like Orbitz, Stolichnaya and Subaru. The "Logo Unbuttoned" title echoes the phrase "Live Unbuttoned," which is the theme of a worldwide campaign for Levi's 501 that was introduced in July by a Levi Strauss agency, Bartle Bogle Hegarty. The budget for the campaign, which also includes promotions, events and social media, is estimated at more than \$1 million. Levi's 501 will be the sole sponsor of a program block that Logo plans to introduce on Oct. 12, "Saturday Nights Unbuttoned Presented by Levi's," which will run from 1 to 3 a.m. on Sunday mornings.

LAKE WORTH—By a vote of 3 to 2, and after more than a year of delays, the Board of Trustees of Palm Beach Community College finally voted to offer domestic partner health insurance to college employees.

Trustees William Berger, Wendy Link and David Tally voted in favor of the proposal. Chairperson Kenneth Kirby and former Chairperson Carolyn Williams both voted "no."

"Thanks to the persistence of President Dennis Gallon and Human Resources Director Ellen Grace, all employees of Palm Beach Community College will soon be able to purchase affordable health care for their families," said Rand Hoch, President of the Palm Beach County Human Rights Council.

The Council, which has been in the forefront of domestic partner benefits in Palm Beach County for the past twenty years, first asked PBCC to consider domestic partner benefits in 2005.

Last year, the Florida Community Colleges Risk Management Consortium also asked the college to offer domestic partner health insurance. The Consortium provides health insurance for PBCC and 21 other Florida community colleges.

While both Gallon and Grace have long advocated for domestic partner benefits, two trustees -- Carolyn Williams and Kenneth Kirby -- consistently opposed offering domestic partner health insurance to college employees.

"Trustees Williams and Kirby sought to impose their narrow personal opinions as to what constitutes a family on the college's faculty and staff," said Hoch. "Fortunately, Trustees Berger, Link and Tally understood what was in the best interests of Palm Beach Community College, and acted accordingly."

"Previously, each time the trustees were poised to provide equal access to family benefits, Trustees Williams and Kirby prevented that from happening," said Hoch. "Today, they finally ran out of ways to delay and deny."

SAN FRANCISCO—John Burnside, 90, surviving partner of Harry Hay, died on Sunday 14.

John's death came within weeks after diagnosis of a large, rapidly spreading, inoperable tumor deep within his brain. Most members of the Circle of Loving Companions, who had organized and provided financial and health support for Harry and John in their last years, were present at the time of his passing.

John was the inventor of the Teleidoscope and the Symmetricon, and was the partner of Harry Hay for 39 years.

Burnside met Harry Hay in 1962 at ONE Incorporated. He fell in love and the two became life partners. They formed a group in the early 1960s called the Circle of Loving

Companions that promoted gay rights and gay love. In 1966 they were major planners of one of the first gay parades, a protest against exclusion of homosexuals from the military, held in Los Angeles. In 1967, they appeared as a gay couple on the Joe Pyne television show.

In the late 1970s, they founded, along with Don Kilhefner and Mitch Walker, the Radical Faeries.

John had recently moved to 501 Ashbury in San Francisco, the flat of longtime Bay Area activist, Pride Parade Chairperson, and 2008 Grand Marshall Joey Cain. Round-the-clock companionship, care, and support was provided.

LOS ANGELES—Brad Pitt has announced Wednesday that he's donating \$100,000 to fight California's Proposition 8, a November ballot initiative that would eliminate same-sex couples' right to marry.

"Because no one has the right to deny another their life, even though they disagree with it, because everyone has the right to live the life they so desire if it doesn't harm another and because discrimination has no place in America, my vote will be for equality and against Proposition 8," the actor said in a statement.

Pitt's donation marks the largest thus far to the anti-Prop. 8 campaign by an A-list celebrity.

BRASILIA, Brazil—The AP reported that Brazil's president has come out in favor of same-sex unions.

President Luiz Inacio Lula da Silva said that in Brazil, "there are men living with men, and women living with women" who "build a good life together." But a proposed law that would give all same-sex couples rights equal to those enjoyed by married heterosexuals has been stalled in Brazil's Congress for more than a decade.

Silva said in an interview by the government-run TV Brasil that politicians who oppose same-sex unions and yet seek the votes of gay men and women during elections are "hypocrites."

point out that we don't belong to their church and ask why their religious views should be forced on us they just turn away, but at least they had to think a bit. Most, however, will be at a loss and say something to the effect that they aren't *that* kind of Republican.

We then pounce: "Then you will vote against Amendment 2." A simple statement, no forcefulness, not a question at all. If they waiver we remind them that words don't mean much, it's actions that count and so far the Republican Party's actions have not been positive, or even neutral, towards GLBT Americans. It is up to them to vote their convictions.

This is approach is especially effective when addressing candidates for sheriff. Why would we vote for someone whose party persecutes us? Their party believes we should have our rights reduced: marriage in Florida, California and Arizona and adoption in several other states. How can we be sure that a sheriff from a party that holds us in less regard will fully protect us?

If you can't bring yourself to personally approach people, try it on your friends – some of them will be willing to talk to others. Make sure you go to [www.FairnessForAllFamilies.org](http://www.FairnessForAllFamilies.org) and educate yourself on the impact Amendment 2 will have on non-gay couples. Direct your friends there, too. We need everyone's help.

Even if you can't or won't do the above there is one thing you can do: skip a dinner out and take that money and give it to [www.FairnessForAllFamilies.org](http://www.FairnessForAllFamilies.org). Better yet get with your friends and all of you skip a dinner out. One dinner out, that's all. A few dollars to defeat Amendment 2. You can do it, you can make a difference!


