FOG?

**Gay Rights Tidbits:** The Harrah's chain of Las Vegas casinos and hotels has written a letter to Nevada's legislature warning about a potential loss in gay tourism if Gov. Gibbons vetoes that state's pending domestic partners bill.

In a letter to lawmakers, Harrah's Senior Vice President Jan Jones said that Nevada must compete with other destinations for the growing gay and lesbian business and that there could be a "negative economic impact" if the bill does not become law.

"Our state cannot afford to lose any more revenue to other destinations because of a reputation as a place which is not socially or politically the right place to do business or to vacation," Jones stated in the letter. Gays and lesbians have the highest disposable income of any segment of the population, according to Jones. "Our company does aggressive marketing to this community," Jones said Wednesday. "How can we say to them 'we want your business, but we don't care about your rights.'"

Honesty is the best policy, and diversity is the right thing to do. Harrah's has accomplished both with this letter of support for the Nevada domestic partnership bill, which the governor promises to veto.

What does this mean to you here in Florida? Think about it, if we turn out in large numbers, we get recognized by politicians as a voting bloc (nevermind that we don't all vote the same, politicians identify potential votes by groups and ignore individual variations). But more importantly businesses recognize us as an economic force and it's the businesses who finance campaigns and pay the lobbyists. So that makes it doubly important for those who can be out to be OUT and for everyone to come out for events in our own community where the crowd masks individual identity.

Make no mistake about it, the politicians kept count at our Pride Festivals as did businesses. They may report one-half to one-third the actual total, but they know

TALAHASSEE—On May 14 the Florida Court of Appeals unanimously reversed a lower court ruling. The result of the Appellate Court ruling means that although adoptions by gays and lesbians is prohibited in Florida (the only state that explicitly targets gays – other states ban gay adoption by limiting it to married couples) adoptions granted in other states must be recognized in Florida. The unanimity of the decision is also important, as rulings by divided courts are easier to dispute.

The NCLR explained that “The Florida Court of Appeals unanimously reversed a lower court ruling and held that Florida must give full faith and credit to adoptions granted to same-sex couples by other states, holding that Lara Embry, the plaintiff in the case, ‘must be given the same rights as any other adoptive parent in Florida.’ The court based its decision on the Full Faith and Credit Clause of the federal constitution and a Florida statute requiring Florida to honor adoption decrees from other states. Noting that ‘there are no public policy exceptions to the full faith and credit which is due to judgments entered in another state,’ the court concluded that ‘regardless of whether the trial court believed that the Washington adoption violated a clearly established public policy in Florida, it was improper for the trial court to refuse to give the Washington judgment full faith and credit.’ A concurring opinion further noted that Embry’s ‘same-sex relationship with [the other parent] is irrelevant for the purpose of enforcing her rights and obligations as an adoptive parent.”

“The case arose when Lara Embry filed a petition seeking shared custody of a child she had raised with her former partner, Kimberly Ryan. The couple had two children together. Each gave birth to one child, and each adopted her non-biological child through a second-parent adoption in the state of Washington, where the family lived. The couple moved to Florida, and their relationship ended several years later. They agreed to share custody of both children and did so successfully until Ryan unilaterally decided to separate the children, who are deeply bonded as siblings, and cut off all contact between Embry and one of the children.”

There is also a case making its way through the courts challenging the gay adoption ban and

many expect that case to make it to the Florida Supreme Court for resolution of the matter long before the law can be repealed legislatively.

ALBANY—A report on [newsday.com](http://newsday.com) on May 12, stated that the New York State Assembly passed a same-sex marriage bill by a larger margin than the last time they considered the bill two years ago.

The bill’s fate in the State Senate remained uncertain, Majority Leader Malcolm Smith acknowledged. Efforts to persuade wavering senators will be aided by the lower chamber’s action, he said. Despite having a majority at least six of 32 Democratic Senators have said they oppose the bill. He has said he will not bring the measure to a vote without first knowing it will pass.

In the 150-member Assembly Tuesday, 89 voted in favor of legalizing civil marriages between two men or two women, up from 85 in 2007. Advocates of same-sex marriage hope the larger victory margin will increase pressure on the Senate, which didn’t take up the bill under Republican leadership two years ago.

NEW ORLEANS—A Queerty column on May 13 gleefully reported that Republican Louisiana Sen. David Vitter, who is about as homophobic as they come, a staunch supporter of abstinence-only sex education, one who tried amending the U.S. Constitution to ban same-sex marriage, the guy who said, “I don’t believe there’s any issue that’s more important than this one.” The report was unclear on whether that before or after Vitter compared the effects of gays getting married to Hurricane Katrina. The report pointed out that you may recall Vitter’s name was on the D.C. Madame’s list, because he likes his hookers! Or did as a mere Representative.

Now it seems Senator Vitter has an imposing opponent for his seat. Perhaps buxom is a more accurate description of Stormy Daniels, the porn star who plans on giving Vitter a fight for his Senate seat — and someone who has the opposite stance on all of Vitter’s “family values.”

An interview this week, the star of such films *Tit Happens* and *Super Size Meat* comes out swinging on equality. Says Daniels: “One of the joys of being an American is equal treatment. ...

NEW YORK—The gay-religion blog on [blogspot.com](http://blogspot.com) reported that the former Catholic Bishop Of Milwaukee has admitted he is gay.

The Roman Catholic archbishop who resigned in 2002 over a sex and financial scandal involving a man describes his struggles with being gay in an upcoming memoir about his decades serving the church.

Archbishop Rembert Weakland, former head of the Milwaukee archdiocese, said in an interview Monday that he wrote about his sexual orientation because he wanted to be candid about “how this came to life in my own self, how I suppressed it, how it resurrected again.”

Called “A Pilgrim in a Pilgrim Church: Memoirs of a Catholic Archbishop,” the book is set to be released in June.

“I was very careful and concerned that the book not become a Jerry Springer, to satisfy people’s prurient curiosity or anything of this sort,” Weakland told The Associated Press. “At the same time, I tried to be as honest as I can.”

AUGUSTA, ME—Lesgetreal.com reported on May 23 that Maine’s Catholic Church may lose its tax exempt status due to its actions in its opposition to Maine’s same-sex marriage law.

It has been alleged that the Roman Catholic Diocese in Maine is violating the IRS tax exempt status by gathering signatures for an attempt to repeal Maine’s same-sex marriage law. The Empowering Spirits Foundation has filed for an investigation into the Catholic Church’s gathering of signatures in the current ballot petition. The Catholic Church is adamant about putting an end to the bill, and is supporting the attempt to put this to a voter veto in the upcoming election.

Maine became the fifth state to legalize marriage equality in the country, and the second to do so via the legislative process after Vermont. New Hampshire’s bill is currently hung up over wording.

The Diocese believes that it is not breaking their IRS tax status by gathering signature for

the ballot measure; however, because they are doing this in the name of the Catholic Church, they may, indeed, be violating their status. One lawyer stated that the Church may be violating their status as a non-profit because, in gathering these signature under their name, they could be attempting to influence the future vote on this issue.

Meanwhile, marriage equality advocates celebrated their victory today by thanking the legislature for their efforts to make marriage between all individuals a reality.

The fate of the ballot measure is relatively murky. Maine is already teetering on the edge of having a majority favor same-sex marriage, and the state already has civil unions. The attempt to get a similar measure on the ballot to repeal civil unions failed to reach the threshold of signatures necessary to get it before the voters.

The outcome of this issue may have major repercussions in Florida and other states where signatures for citizen initiatives were orchestrated through churches. In Florida the web site for the backers of Amendment 2 had extensive instructions for churches on what to do and say and even had downloads for inserts for church bulletins and petitions to be signed at church services.

MADISON—As reported in *LezGetReal*, The Wisconsin State Supreme Court formally issued notice it intends to review the case of *McConkey v. J.B. Van Hollen, et al.*...

This is a case where a University of Wisconsin-Oshkosh professor William McConkey and father of a gay child, is challenging the legality of the 2006 referendum amendment to Wisconsin's constitution banning same-sex marriage and civil unions. McConkey argues that amendment should be nullified because the two questions in the referendum should have been voted on separately.

McConkey's case was dismissed last year by Dane County Judge Richard Niess, who said in his ruling those the issue is "two sides of the same coin."

But McConkey appealed to the Wisconsin District 4 Court of Appeal, who in turn asked the Wisconsin Supreme Court to review the case, saying, "The validity of the marriage amendment is a matter of significant public interest with statewide implications."

A win in the Wisconsin Supreme Court would not legalize gay marriage in Wisconsin, as the state would still define marriage as a heterosexual

union, but it would allow gay and lesbian couples who have been denied a marriage license the right to file lawsuits in Wisconsin to change that.

A win in the Wisconsin Supreme Court will give marriage equality supporters elsewhere a model to begin taking on similarly written Defense of Marriage amendments in other states, making this a very important court case indeed.

The decision by the Wisconsin Supreme Court is expected sometime in fall or winter of 2009.

WASHINGTON, DC—A UN Dispatch stated that Congress has inserted a provision into the State Department authorization budget that would require the State Department to confer the same benefits to same-sex partners as it does to married couples.

Congressman Howard Berman, Chair of the House Committee on Foreign Affairs, included the provision in the Foreign Relations Authorization Act for Fiscal Years 2010 and 2011 (H.R. 2410) to "end the long-standing practice of excluding the committed partners of Foreign Service officers from the benefits routinely provided to the spouses and children of officers serving abroad." The provision now must make its way through the budget process, including the conference committee where many-a-well intentioned proposal hits the chopping block. But in this case, it would be hard to imagine that the Senate Foreign Relations Committee, which is lead by Chairman John Kerry and the moderate republican ranking member Richard Lugar, would do anything to strip out this provision.

This would be progress. For too long, gay and lesbian diplomats have had to chose between their families and their service. "I'm happy that efforts to redress these discriminatory policies are being undertaken," emails Michael Guest a former Foreign Service officer currently affiliated with the Center for Global Equality. "This is all about ensuring the safety, effectiveness and equal workplace conditions for those who serve our country abroad, and for the families who accompany them on those assignments." Amen!

SAN ANGELO, TX—From *SanAngelo.com*, the web site for the local newspaper.

J.W. Lown has left his position as mayor of San Angelo to pursue a personal relationship.

Lown said in a telephone call late Wednesday afternoon from Mexico that he has started a relationship with someone who does not have legal status in the United States.

Lown said he did not want to take the oath of office knowing he was "aiding and assisting" someone who was not a citizen.

"I made the final decision when I knew it was the right decision to make for me and my partner and our future — and for the community," he said.

Lown was scheduled to take the oath of office Tuesday for his fourth term as mayor but did not appear at the event.

Lown said the man came to the United States five years ago. He attended Angelo State University. Lown said the relationship started after March.

Lown and the man are in Mexico awaiting a visa to come back legally.

"I did the best I could," Lown said. "I had to get down here and get everything in order to make a life for myself."

"I didn't make this decision lightly," he said. "I have to give this a chance."

He said he and his partner will come back to San Angelo if "the people of San Angelo will welcome me back."

Lown abruptly resigned his post only 10 days after achieving a landslide victory for his fourth term.

Lown won re-election with 89.34 percent of the vote. The mayor in San Angelo is elected at-large, serves a two-year term and has a seat on the City Council. The mayor has no additional power beyond that of his fellow council members, who are elected from single-member districts.

In his resignation letter, Lown said, "While I know that the timing of this announcement is less than ideal, I have my own compelling reasons for making this decision. I have made thousands of decisions on behalf of our community, and I weighed this decision in the same manner that I approached other decisions."

Dominguez said he was surprised by the letter. "I think the best indication we have is it was a personal decision he felt was in his best interest and in the community's best interest," Dominguez said. "He reiterated how important the community is to him."

Several council members were at the news conference, and while they were surprised with Lown's decision to step down, they said people should respect Lown's wishes for privacy.

Jon Mark Hogg, council member and mayor pro tem, said "I think it goes without saying we lost a

great public servant with Mayor Lown. He cared about and advocated for the city of San Angelo. Mayor Lown has made positive improvements with the city."

San Angelo, pop. 88,439, is the county seat of Tom Green County, in West-Central Texas. As of the 2000 census, the city had a total).

The city began as a frontier town near Fort Concho, which was established in 1867. Goodfellow Air Force Base is located at the city's outskirts

SPRINGFIELD, IL—A column in the *Washington Blade* reported that the Illinois General Assembly is expected to legalize civil unions.

Citing Rick Garcia, political director for Equality Illinois, who said he's "absolutely" expecting the full state House and the Senate to pass a civil union measure either and the bill has support from Illinois Gov. Pat Quinn (D).

The House Youth and Family Committee, chaired by Rep. Greg Harris, who's gay, and represents the area of Chicago that includes the gay business district, intends to attach an amendment legalizing civil unions to a "shell bill" that's already been approved by the Senate, according to Garcia. Upon passage in the House, the bill would be sent to the Senate within hours for a vote of concurrence.

Garcia said Illinois lawmakers often use "shell bills" to pass legislation expediently. He said it's necessary to legalize civil unions through this method because the legislative session ends May 30 and the approach limits the time that opponents of civil unions can lobby lawmakers.

"We get it out of the House and then senators only have a few hours of being beat up by our opponents rather than three days or a long weekend," he said. "Since there is a perfectly legitimate way of doing it in one day, that's what we're going to do."

The official purpose of the "shell bill" that lawmakers are planning to amend relates to death and estate issues. *continued on page 25*

On March 5, the House Youth and Family Committee reported out legislation that would have legalized civil unions with a vote of 5-4. The amendment that lawmakers intend to attach to the "shell bill" has identical language to the legislation, Garcia said.

Garcia said Equality Illinois has nine lobbyists working as either full-time staffers or contractors to encourage lawmakers to vote in favor of civil unions. Other groups assisting in passing the measure include the American Civil Liberties Union, the AIDS Foundation of Chicago and the Service Employees International Union, Garcia said.

Should the measure become law, both gay and straight couples could enter into civil unions. As there's no explicit language regarding an effective date, couples could start entering into civil unions 30 days after the bill is signed into law, Garcia said.

The measure contains language noting that the establishment of civil unions would not interfere with the practices of any religious group and that any religious institution could decide for itself whether or not to solemnize or officiate a civil union.

DENVER—The Advocate.com reported on May 21 that Colorado governor Bill Ritter discreetly signed a bill that would give same-sex domestic partners of state employees the same benefits as spouses of heterosexual employees.

"It's an important piece of legislation that will help make sure the state can attract and retain good employees and compete with the private sector," said Rep. Mark Ferrandino, one of the bill's sponsors.

There has been little public protest, but the governor's decision still met with criticism from social conservative groups. "If the signing of Senate Bill 88 did not disregard the desires of the people, why was it signed in the dark of the

night?" Jessica Langfeldt, legislative director of Colorado Family Action, said in a statement.

Mindy Barton of Equal Rights Colorado said the publicity isn't as important as the act of signing the bill. "When you're looking at the short time frame after the close of the session, there's just a landslide of bills the governor is looking at," Barton said. "I'm very happy that he did sign this important piece of legislation."

NEW MEXICO—Statement by Friends & Family of Rodger McFarlane on his Death

"It is with deep sadness that we announce the death of our friend, colleague, and hero, Rodger McFarlane. A pioneer and legend in the lesbian, gay, bisexual and transgender (LGBT) civil rights and HIV/AIDS movements, Rodger took his own life in Truth or Consequences, New Mexico. In a letter found with his remains, Rodger explained that he was unwilling to allow compounding heart and back problems to become even worse and result in total debilitation. We know that Rodger was in a great deal of pain. Already disabled in his own mind, he could no longer work out or do all the outdoor activities he so loved. He was also now faced with the realization that he could literally not travel, making employment increasingly difficult. As his friends and family, we thought it was important that we communicate to the world that it has lost an amazingly wonderful individual who contributed so mightily to our humanity.

Rodger approached every aspect of his life with boundless passion and vigor. While many people go their entire lives wanting to be good at just one thing, Rodger excelled at virtually everything he did. Brilliant activist and strategist, decorated veteran, accomplished athlete, best-selling author, and humanitarian are just a few of the accolades that could be used to describe our friend. To know Rodger was to love an irreverent, wise-cracking Southerner who hardly completed a sentence that didn't include some kind of four-

letter expletive. He fought the right fight every day, was intolerant of silence, and organized whole communities of people to advocate for justice. These were traits that endeared him to us and are traits that make his legacy incredibly rich and powerful.

The power of Rodger's many personal and professional accomplishments cannot be denied. He was on the forefront of responding to the AIDS epidemic that ravaged our country – and specifically the gay community – in the 1980's. Before HIV even had a name, in 1981, Rodger set up the very first hotline anywhere; he just set it up on his own phone. That was the Rodger we knew. A born strategist and leader, Rodger took three organizations in their infancy and grew each into a powerhouse in its own way, empowered to tackle this national tragedy.

One of the original volunteers and the first paid executive director of Gay Men's Health Crisis, the nation's first and largest provider of AIDS client services and public education programs, Rodger increased the organization's fundraising from a few thousand dollars to the \$25 million agency it is today. Until his death, he was the president emeritus of Bailey House, the nation's first and largest provider of supportive housing for homeless people with HIV.

From 1989 to 1994, he was executive director of Broadway Cares/Equity Fights AIDS (BC/EFA), merging two small industry-based fundraising groups into one of America's most successful and influential AIDS fundraising and grant-making organizations. During his tenure at BC/EFA, annual revenue increased from less than \$1 million to more than \$5 million, while also leveraging an additional \$40 million annually through strategic alliances with other funders and corporate partnerships. Rodger was also a founding member of ACT UP – NY, the now legendary protest group responsible for sweeping changes to public policy as well as drug treatment and delivery processes.

Most recently, Rodger served as the executive director of the Gill Foundation, one of the nation's largest funders of programs advocating for LGBT equality. He transformed the Foundation by sharpening its strategic purpose. He focused its philanthropy in the states, aligned its investment with political imperatives and forged relationships with straight allies that helped to further both the LGBT movement as well as the greater progressive movement. Rodger was instrumental in the creation of the Gill Foundation's sister organization, Gill Action. The brilliance of Rodger's vision is being seen

today as important protections for LGBT people become a reality in more and more states.

No one will ever doubt that our friend Rodger lived a rich and complete life. A proud U.S. Navy veteran, Rodger was a licensed nuclear engineer who conducted strategic missions in the North Atlantic and far Arctic regions aboard a fast attack submarine. A gifted athlete, he was a veteran of seven over-ice expeditions to the North Pole. He also competed internationally for many years as an elite tri-athlete, and in 1998 and 2002, competed in the Eco-Challenges in Morocco and Fiji, where he captained an all-gay female-majority team.

In spite of the fact that Rodger never completed college, he was an accomplished and best-selling author and the producer of works for the stage. Rodger was the co-author of several books, including *The Complete Bedside Companion: No Nonsense Advice on Caring for the Seriously Ill* (Simon & Schuster, 1998), and most recently, Larry Kramer's *The Tragedy of Today's Gays* (Penguin, 2005). In 1993, he co-produced the Pulitzer Prize-nominated production of Larry Kramer's *The Destiny of Me*, the sequel to *The Normal Heart*.

Rodger had a reputation as a hard-ass. That reputation didn't do him justice. Many of us will remember Rodger as a caregiver, a man who nursed countless friends and family members battling cancer and AIDS. He was the most compassionate and giving of friends, especially to those in physical or emotional distress.

His many achievements were recognized throughout his life. Most recently, he had received the Patient Advocacy Award from the American Psychiatric Association. Other honors included the New York City Distinguished Service Award, the Presidential Voluntary Action Award, the Eleanor Roosevelt Award, and the Emery Award from the Hetrick Martin Institute, as well as Tony and Drama Desk honors.

How do you sum up someone's life in just a few words? It's impossible and you can't. To commemorate Rodger's life, his friends will organize celebrations of his, the details of which are still in the planning stages. If Rodger was anything, he was a character through and through; there are, quite literally, thousands of "Rodger stories." That's part of what made him such a special person. During our celebrations, we'll share some of these stories and reflect on the many legacies left by our friend for life, Rodger McFarlane.


